**APPOINTMENTS & INFORMED FINANCIAL CONSENT**

1. All appointments are strictly time and complexity based. We ask that you make your best estimate of the appropriate appointment length when booking to cover the health concerns you wish to discuss.
2. Doctors must adhere to their daily schedule for the safety and well being of all patients. If your medical concerns require more time than what you have scheduled, your doctor will discuss this with you during the consultation to provide informed financial consent. At the absolute discretion of the doctor, they may accommodate the extended time (which will incur a higher fee based on time & complexity) or ask you to rebook a follow up appointment for your remaining concerns.

**BILLING & FEE TRANSPARENCY**

3. Fee changes will be proactively communicated to patients prior to their appointment via website updates, booking platforms, and clinic signage.
4. Full payment is required at the end of your consultation.
5. Telehealth consultations are billed at the scheduled fee; payment is due over the phone post consultation.
6. Higher private fees apply for after hours or weekend appointments, including for children of all ages.
7. The fee for iron infusions does not include the cost of the infusion kit. Some vaccinations, supplies, or procedures may also incur additional out of pocket costs. Please ask reception.
8. Overdue accounts (30+ days) may incur interest. In the event that an account is passed to a debt collection agency or requires legal action for recovery, the patient will be held responsible for all associated debt collection fees and legal costs incurred by the practice.
9. Patients with Worker's Compensation or CTP claims are responsible for fees on the day of consultation until a valid insurer claim number is provided and accepted for direct billing.
10. Fees apply for medical reports, forms, and referrals completed outside of a standard consultation. Inquire for charges.

**MEDICARE & BULK BILLING**

11. We limit bulk billing strictly to the following cohorts and appointment types: Age Based Health Assessments (e.g., 45 to 49 years old, >75 years old). GP Care Plans & Reviews (Please note: Not all GP Care Plans qualify for bulk billing; please discuss eligibility with your doctor). DVA Card Holders (Gold card holders, and White card holders under eligible conditions only). Children under 10 years old (Monday to Friday only).
12. Reduced fees apply strictly to valid Age Pension Concession Card holders (over 65) only.
13. Our practice participates in the Bulk Billing Practice Incentive Program (BBPIP). Eligible cohorts (such as concession card holders or children) must be formally registered and linked to our practice via MyMedicare to access specific benefits, including bulk billed longer telehealth consultations.
14. To comply with Medicare billing legislation, bulk billed patients (or their responsible assignor) are required to provide an electronic or physical signature at the time of the consultation to officially assign their Medicare benefit to the provider.
15. Eligible Medicare rebates can be processed electronically direct to your bank account or as an instant EFTPOS rebate. Patients are responsible for ensuring their Medicare and contact details are current. All fees remain the patient's liability until any applicable Medicare rebate is fully processed and received.

**CANCELLATIONS & MISSED APPOINTMENTS**

16. Please provide maximum notice for cancellations. Appointments missed or cancelled with less than 3 hours notice will incur a non Medicare rebateable cancellation fee, payable upon cancellation or non attendance.

**CLINICAL SAFETY & PRIVACY**

17. We reject the "no news is good news" assumption. Managing your health is a shared responsibility. Patients are responsible for ensuring they receive their test results and must book a follow up appointment to discuss them. Due to privacy and safety guidelines, reception staff are strictly prohibited from releasing raw data or test results over the phone.
18. If you request documents (such as referrals or results) via email, you must expressly acknowledge and accept the privacy risks of interception. Clinical staff do not provide medical advice via email or social media.
19. We strictly protect your health data. When transferring medical records to a new practice, a basic health summary can usually be transferred for free. However, transferring a full historical medical file incurs an administrative fee to cover the resources required to collate and securely transmit the data. This process can take up to 45 days in NSW.

**CODE OF CONDUCT**

20. We operate under a strict Zero Tolerance policy to protect our staff and community. Shouting, swearing, threats, aggression, and discrimination will not be tolerated under any circumstances. Such behavior will result in the immediate and permanent termination of the doctor patient relationship and the formal transfer of your care to another clinic.

**PATIENT AGREEMENT**

21. We value transparency and clear expectations so we can focus on providing you with the highest standard of care. By scheduling, attending, or participating in an appointment with Kirrawee Doctors, you confirm that you have read, understood, and agree to be bound by the practice terms, conditions, and billing policies outlined above. Please note that this document establishes a legally binding agreement between you (the patient) and Kirrawee Doctors. Your act of booking a visit or continuing to receive care with our practice serves as your full and unconditional acceptance of these terms, alongside any future updates, ensuring a clear and respectful partnership in your healthcare.
